Once all documentation has been verified, your request will be placed on the next available board meeting agenda. ALL documentation for NEW requests must be returned to your requested school no later than March 29th of the given year. New requests will be heard at the June board meeting.

Once the board has made a decision, the district office designee will mail the parent(s)/guardian(s) a letter with the decision. If approved, parent(s)/guardian(s) may pre-register their child for the approved school year. **Board approval for non-resident students will be valid for 90 days from the board approval date. If the student has not enrolled or pre-registered at an Edgefield County school, or, if the student attends school in another district after board approval, the board decision becomes invalid and the parent(s)/guardian(s) will need to re-apply. Repeat applications for the same school year will be subject to verification and approval of the superintendent, or his/her designee prior to being placed on the next Board meeting agenda**

**NOTE: Upon approval, parent(s)/guardian(s) will be responsible for the out-of-district tuition fee set by the Board each year.**

## Regulations and Guidelines for Out-of-District Students

1. All district and school policies and rules will apply to all Out of District students upon enrollment in an Edgefield County school. Failure to follow policies and rules can result in enrollment being revoked.
2. Even though a request for a particular school may be made, Edgefield County School District reserves the right to determine school placement.
3. Any out of district student who desires to enroll in the Edgefield County School District must be in good standing with his/her home (residing) school/district.
4. A release from the home (residing) school district must be obtained by the enrolling student and presented to Edgefield County School District.
5. Students living outside of Edgefield County must pay a tuition fee to enroll in the Edgefield County School District.
6. Enrollment of any out of district student must not cause financial burden for Edgefield County School District. Any excess costs in educating an out-of-district student must be paid by the parent/guardian and/or home district.
7. Transportation will be provided by the parent/guardian and not Edgefield County School District.
8. Continued enrollment in Edgefield County School District for any out of district student is contingent upon cooperation by both students and parent/guardian. Problems with academics, discipline, attendance (to include tardies) or **failure to pay Out of District tuition fees** can result in enrollment being revoked.
9. Failure at any time to comply with the above regulations or by providing false information can result in the students return to his/her home (residing) district. Reimbursement of tuition, if applicable, will be issued on a prorated basis.
10. Out of district requests are good for one year only. Continued enrollment requires a request to be made annually.

I have read the above regulations/guidelines and understand that my child's enrollment in Edgefield County School District is contingent upon compliance with the regulations and guidelines.
